## 1. Minutes of the Annual General Meeting held on 22 February 2014

The AGM in 2014 had simply inaugurated the new, amalgamated NottsWatch and elected the trustees. Copies were circulated and the meeting accepted them as a true record, nem con.

## 2. Matters arising from the Minutes

## 3. Changes to the Constitution

The Board had proposed and solicited the views of all the membership and, since there have been no objections, the revised Constitution published on the NottsWatch web site and previously circulated via the alert system was adopted by the meeting, nem con.

Copies of the principal changes were circulated at the meeting and in response to a question from the floor, it was agreed that NottsWatch should be more fully recognised as the brand for Nottinghamshire Neighbourhood Watch. NottsWatch is clearly stated as an abbreviation for Nottinghamshire Neighbourhood Watch in the heading to the constitution and it was thus agreed that the Trustees should examine the possibility of registering it to prevent use by others.

#### 4. Annual Report

NottsWatch Chairman, Dr David Rhodes, reported that it had been a year of transition and happily a NottsWatch team worthy of the name has emerged. The them and us has disappeared and the uncontested changes to our Constitution bear testimony to this.

It was also a year in which we started to examine more seriously the changing context in which we operate; not just us but the Police, National NW and the public-sector agencies too.

Austerity, the changing nature of crime (cyber crime and domestic violence), increasing numbers of elderly and vulnerable people and the ever wider spread of digital networks and "apps" mean that more than ever we must learn to look after each other.

Thus the Review of NottsWatch has been timely and will shortly be published. Those who have seen the report have been very complementary and we look forward to it making and impact.

The PCC provided £25,000 for NottsWatch to promote NW in areas of the City County where crime and anti-social behaviour are high; not an easy task but one we have bravely addressed and made headway. A report on this will be out in with the detail and respect for those who contributed properly recorded. NottsWatch here record their thanks to the PCC for the grant. 2015-16 looms and with new leadership and the increasing realisation that real collaboration between the public and voluntary sectors is the way NW looks set for a challenging future as part of the wider development of socially cohesive communities.

The County Council well understands this latter point and is sponsoring volunteers to promote new schemes in the Partnership Plus areas of the County throughout 2015-16 to the value of £10,500. NottsWatch thanks the Council for providing this money and Councillor Gilfoyle for his help in obtaining it.
